No Lease of a horse in the Society's records shall be effected unless the Lease Application is signed by the Owner/Lessor and Lessee of the horse, the original copy of the Certificate of Registration or Foal Recording Certificate and the prescribed fee have been submitted to the Society. Leases will not be effected to Non-Members of the Society. Once the Lease has been effected, a copy of the Certificate of Registration or Foal Recording Certificate which incorporates the Lessee details shall be supplied to the lessee. Once the Lease Termination has been effected, the Certificate of Registration or Foal Recording Certificate which incorporates the Lease Termination details shall be supplied to the Owner/Lessor.

The Society recommends that the Owner/Lessor and the Lessee retain a copy of this document.
