DNA Profile - Parentage

Where horses are required to be DNA Profiled, the Society requires sire and/or dam verification (where possible).

From 1st October 2025, DNA Parentage Testing for all NEW Applications for Registration is included in the registration fee and this form is not required.

Until 1st October 2025, for all NEW Applications for Registration where horses are REQUIRED to be DNA Profiled (AI and ET progeny and progeny of genetic disorder carriers or affected), or the member has REQUESTED the horse be DNA Profiled, the reduced registration fees from 1st October 2025 will apply.

- DNA Profile ONLY **\$95** No DNA profile for sire and/or dam, **OR**
- DNA Parentage Verification **\$95** Sire & dam must have a DNA profile.

Genetic Disorder Testing - GDT

For samples received from 1st July 2025, 6 panel Genetic Disorder Tests will include: **OLWS, HYPP, HERDA, PSSM1, GBED, MYHM**. For samples received prior to 1st July 2025, 6 panel Genetic Disorder Tests included: OLWS, HYPP, HERDA, PSSM1, GBED, MH.

Genetic Disorder results are noted on the horse's registration and are published on the Society's Online Stud Book. Genetic Disorder results for **POSITIVE HORSES (carrier or affected)** must be disclosed at sales and all breeding opportunities.

NEW Applications for Registration - All progeny of horses with a POSITIVE Genetic Disorder must be DNA profiled and Genetic Disorder Tested. Sire Registration of **SIRE REGISTERED ASH STALLIONS** are **SUSPENDED**, if the DNA profile and Genetic Disorder Testing has not been finalised with the Society.

- DNA Record & 6 Panel GDT **\$225**
- DNA Record & 1 Panel GDT **\$140**
- 6 Panel GDT (already DNA profiled with ASHS) **\$130**

In the event, hair in storage is insufficient or not available, a second sample will be required and an additional fee of \$65 will apply.

After the application and payment has been received, a DNA kit will be issued to the Registered Owner with instructions for the owner (or authorised agent) to collect a hair sample and return it to the testing laboratory. *The Society will not release genetic marker information to horse owners.*
